1. Riders, owners, and trainers must apply for membership each show year. The show year is December 1 through November 30.
2. Membership entitles you to compete for year end awards, notification of GCHSA shows and meetings and to receive the GCHSA rules, newsletter and reports on GCHSA points.
3. Membership is required to receive points toward year end awards. For year end Equitation awards, riders and their trainer(s) must be members (but their horses/ponies need not be registered). For year end awards in the Hunter, Jumper and combination divisions, horses/ponies must be registered, and their owners AND trainers must be members.
4. Horses/Ponies with annual registrations must re-register each year. Annual registration is \$5. Remember OWNERS must be current members as well.
5. Sale of a horse or pony must be reported to the GCHSA and a transfer fee of \$5 must be paid before points are transferred to the new owner. The name may be changed at the same time for an additional \$5.
6. Point accumulation starts upon receipt of application and fee by the Membership Secretary. A check returned unfunded to the GCHSA will void the application and any accumulated points.
7. If you have submitted an application and fees and you or your horse/pony do not appear on membership lists, please contact Membership Secretary immediately.
8. The 2010 GCHSA rules and news will be posted on the GCHSA website, www.gchsa.org.
