About this form

- An individual whose usual place of abode is outside the UK can use this form to apply to have his or her UK rental income paid without deduction of UK tax. Approval of the application does not make the rent exempt from UK tax. The individual must include the rent in any Self Assessment Tax Return HM Revenue & Customs sends. Use this form only if you are an individual. A company should use form NRL2, and a trustee should use form NRL3. Use the Guidance Notes for form NRL1 to help you complete this form. If you need more space attach a separate sheet. Send your completed form to HM Revenue & Customs Centre for Non-Residents at the address on page 3.
