

PLAYER'S CONTRACT

EACH INDIVIDUAL MUST READ THE PLAYERS' CONTRACT BEFORE SIGNING HIS/HER SIGNATURE ON THE ROSTER. NAMES OF INDIVIDUALS ON THE ROSTER THAT HAVE NOT SIGNED THEIR SIGNATURE WILL NOT BE ELIGIBLE TO PARTICIPATE IN THE LEAGUE.

BY AFFIXING MY SIGNATURE TO THE PLAYERS' ROSTER, I HAVE READ, UNDERSTAND AND AGREE WITH THE STATEMENT SET FORTH IN PARAGRAPHS 1 THRU 7 ON THIS PAGE.

1. **Release (Injury to myself or to my personal property).** That I release Sumter County, officials, agents and employees for any injury to myself, or for my death, or for property damage on behalf of myself, or my heirs or successors in interest, arising from my participation in the leagues conducted by Sumter County.
2. **Hold Harmless (Injury to others or other property).** That I will indemnify and hold harmless Sumter County, officials, agents and employees from any loss or liability (bodily injuries or death, and/or damage to property, including the loss of use thereof) which results or is alleged to have resulted from my participation in the Adult Leagues conducted by Sumter County.
3. **Player Responsibility for Procuring Insurance.** That I am fully aware that Sumter County carries no medical insurance for any participant and that I am solely responsible for securing my own insurance, and that my team is responsible for securing its own insurance.
4. **MANAGER FAMILIARITY WITH RULES.** My manager has **advised** me that he/she has **read the rules** issued by the League and has **advised** me of the **contents** thereof.
5. **Assumption of Risk.** That I assume **all risks** involved in my participation in the league and that I recognize that I am solely responsible for my decision to participate in any game in the league, and that the above release stated in Section 1 includes, but is not limited to, a release (1) for maintenance or condition of the playing area; (2) for condition of appurtenances thereto (courts, bleachers and gyms); and (3) for equipment supplied by Sumter County.
6. **Sports Skills.** That I am familiar with the skills required to participate in the league conducted by Sumter County, and have satisfied myself that I am **proficient** in these skills and that the above stated release in Section 1 includes, but is not limited to, a release for failure of Sumter County to provide classes for the technical instruction therein.
7. I recognize the strenuous aspect of this sport and that it involves running, jumping and possible physical contact. I hereby attest that I am of physically capable participating in **this activity.**

MANAGER'S STATEMENT

I hereby agree that I will manage my team in accordance with high standards of sportsmanship and require players recognize my authority for control of the team on the field and surrounding areas. Further, I understand that any player who has not signed the OFFICIAL ROSTER, or a ROSTER ADD/ DELETE FORM after reading the PLAYERS' CONTRACT is not eligible to participate in this league. I have read, understood and explained the rules under which this league will be played, to my players.
