I agree that a payment will be charged as soon as this Agreement is received and that additional payments will be charged to my credit card on a monthly basis thereafter during the one year term of this Agreement. If payment is not received within 30 days of due date, coaching calls will be suspended until payment is received. This authority remains in full force and effect throughout the term of this Agreement and shall continue on a month to month basis until Keller Williams Realty, Inc. receives thirty days advance written notification from me of my withdrawal from the Coaching Program. You will have the above-prescribed number of calls, each call for duration of thirty minutes, unless a group call is assigned during Masterminds, Family Reunion, Mega Camp weeks, or your coach's vacation. You are committing to a one-year term by signing this contract, *a covenant commitment*. If mutually agreed, a monthly hold fee of \$200 per month will apply for up to 90 days if you suspend coaching prior to the end of this Agreement. A cancellation/termination fee of \$2,000 will be charged to the payment type on file for any contracts terminated prior to the end of the initial one year term of this Agreement. You will be charged for missed calls; it is your responsibility to notify your coach of any calls you will miss at least two days prior to the day of the call and to work with your coach to reschedule that call. You will be charged for a missed call without opportunity to make up that call if you fail to notify your coach within the time period set forth above. Keller Williams Realty, Inc. will not use or share the personally identifiable information provided herein in ways or for reasons unrelated to the ones herein without your prior written consent. The Client hereby acknowledges and agrees that calls may be recorded for training purposes only.
