The following information is required in order to apply for a Board of Trustees' Scholarship to Chadron, Peru, or Wayne State College. The applicant completes Section I of this form. The applicant must have a guidance counselor or principal complete Section II. The completed application form and letter(s) of recommendation must be mailed to the Nebraska State College System Office, PO Box 94605, Lincoln, NE 68509 by January 15, 2011. Financial need is not a prerequisite for the scholarship. **Notice: All applicants must also complete an application form for admission into the specific college before this scholarship can be awarded.**

To be eligible for a Board of Trustees' Scholarship, the applicant must satisfy **ALL** of the following requirements:

1. Score at least a 25 on the ACT or 1700 on the SAT college entrance exam.
2. Graduate in 2011 from a Nebraska high school.
3. Enroll as a full-time college student at Chadron, Peru or Wayne State in the fall of 2011.
4. Be a resident of Nebraska.
5. Provide at least one letter of recommendation from a high school administrator or teacher.

Other factors may be considered as appropriate, such as grade point average and rank in class.

The Board of Trustees' Scholarship provides tuition remission at Chadron, Peru, and Wayne State Colleges. The award is for a specified college only and is not transferable from one state college to another. **An applicant may apply for a scholarship at ONLY ONE state college.** The scholarships are awarded for one academic year (two semesters) and are renewable for subsequent academic years upon application and academic success, not to exceed eight academic semesters if completed within a total of five years. Recipients of scholarships must enroll as full-time students carrying 12 hours or more per semester. The awards will terminate if the recipient is under academic suspension or probation.
